Helping UK mining companies export technology and expertise and invest in overseas projects, Ros is also responsible for attracting UK investment to support clean growth. She was part of the team responsible for the publication of the UK Critical Mineral Strategy in July 2022. Ros has directed over 50 mining conferences, and created Mining on Top – a conference focused on mining's role in development. Previously, Ros worked for American Express and Barclaycard in a variety of business and commercial roles. She is on the advisory board of Women in Mining Kazakhstan.



Richard Morgan
Head of Government Relations - Anglo American



Richard is based in London, covering global political and sustainability issues in countries where Anglo American has mining operations: Southern Africa (platinum, iron ore and thermal coal, diamonds via De Beers and copper exploration in Zambia and Angola), Brazil (nickel and iron ore), Chile and Peru (copper) and Australia (steel-making coal). There are also projects underway in Finland and the United Kingdom. Richard was previously with the UK Foreign Office with postings in Japan, South Africa and France. He was seconded to Unilever from 2005–2008 covering Africa, the Middle East and Turkey.
