Jeremy Browne

CEO - Canning House

From 2010 to 2012, Jeremy served as Minister of State for Latin America in the Foreign and Commonwealth Office. Since leaving elected office, Jeremy has served as the City of London Corporation's Special Representative to the EU, worked as an International Business Ambassador for Aberdeen Standard Investments (abrdn), and advised the environmental investment firm Renewity.



Helio Bustamante

Programme Manager - ITM Power

Helio, a hydrogen systems expert with 20+ years of experience, has executed significant hydrogen projects. Notable achievements include deploying the first commercial-scale PEM electrolyser for grid balancing (2012), establishing hydrogen refuelling stations with on-site generation (2013-2015), and deploying large-scale hydrogen plants (2016-2018). His work also involves a pioneering 10MW PEM electrolyser for a refinery (2019-2021) and ongoing projects with PEM electrolysis ranging from 24MW to 100MW (2022-2023).



Lord Callanan

Minister for Energy Efficiency and Green Finance

Lord Callanan was appointed Parliamentary Under Secretary of State (Minister for Energy Efficiency and Green Finance) at the Department for Energy Security and Net Zero on 7 February 2023. Previously, he was Parliamentary Under Secretary of State at the Department for Business, Energy and Industrial Strategy, Minister of State at the Department for Exiting the European Union, and Parliamentary Under Secretary at the Department for Transport. Beyond his government roles, Lord Callanan was a member of the European Parliament from 1999 to 2014, and entered the House of Lords in 2014.

Adrian is the Global Energy Advisory Lead at AECOM, offering guidance to a diverse clientele, from utilities to startups.
