Jeremy Browne

CEO - Canning House

Joining in 2018 after 21 years as a British diplomat, including postings in Hanoi and Brazil, he received an OBE for leading the UK Government's efforts during the Rio 2016 Olympic and Paralympic Games. With a geography degree from the University of Sheffield, Jonathan is based in London.



Professor Paul Ekins OBE

Professor of Resources and Environmental Policy - UCL

Paul is a Professor of Resources and Environmental Policy at UCL Institute for Sustainable Resources, University College London. His extensive academic contributions center on sustainable economy conditions and policies, evident in numerous books, articles, and scientific papers. As a member of UNEP's International Resource Panel, he co-authored the report on Minerals Governance (2020) and leads the forthcoming report on financing mineral production for sustainable development. Recognized for environmental policy services, he received an OBE in the UK New Year's Honours List 2015.



Sarah MacKay

Technical Director - ERM

With 30 years of expertise, Sarah, a Hydrogeologist, leads ERM's Water Resource Technical Community. She specialises in water management, corporate reporting of water metrics and risks, and detailed groundwater modeling. Sarah directs impactful water impact assessment programs for national infrastructure projects and addresses long-term legacy issues related to groundwater contamination. Her recent work includes a four-year water reporting program for a global mining company. As a Water Stewardship expert, she collaborates with major industrial companies globally to assess water resource risks under climate change.



Adam Matthews

Chief Responsible Investment Officer - The Church of England Pensions Board

Adam serves as the Chief Responsible Investment Officer at the £3.4 billion Church of England Pensions Board, co-Director of the Investment Team, and founder of the Transition Pathway Initiative (TPI). As Chair of the Global Investor Commission on Mining 2030, he focuses on environmentally responsible mining. Adam also chairs the Mining and Tailings Safety Initiative and co-convenes the effort to establish an Independent Global Tailings Institute. Recognised for his climate change efforts, he received the Canterbury Cross from the Archbishop of Canterbury in 2022.



Natascha Nunes da Cunha

Lead Specialist, Extractive Industries - IDB

Natascha is the Lead Mining Specialist at the Inter-American Development Bank (IDB). With nearly 20 years of experience, she specializes in issues management, stakeholder engagement, and sociopolitical risk analysis, particularly in the intersection of mining and sustainable development. Before joining the IDB in 2016, Natascha was the Corporate Affairs manager at Vale, one of the world's leading mining companies. She holds degrees in International Relations and International Political Economy from the London School of Economics (LSE).



Michael Osborne

Director, Energy, Water and Resources - Arup

Michael is a Director of Arup leading the Energy, Water and Resources business in the North of England. As a Chartered Geologist he is particularly interested in mining and ground water management. Buses including the 8, 17, 25, 46, 59 and 133 stop close to Anglo American.


